Annex 1 to Senate Decision No. 447/15.01.2018

### **Regulation regarding fees (rates) for admission, tuition and graduation for the 2018-2019 academic year**

1. This Regulation establishes the amounts, terms and payment for fees (rates) for admission, tuition, and graduation as well as the method of granting allowances for tuition fees (rates) for all levels and forms of study for Romanian citizens and those assimilated, as well as for foreigners.
2. Tuition fees (rates) for the Master's level will equal at least the amount of fees (rates) established for the undergraduate level.
3. The new amounts of fees (rates) for admission, enrolment and completion of studies related to the 2018-2019 academic year will apply for first year students (bachelor, master's and doctoral level), respectively for students who in the 2018-2019 academic year resume their studies or are required to pay the registration fee for the graduation exams.
4. Tuition fees (rates) are paid by students from Romania and other countries in the European Union, European Economic Area or the Swiss Confederation either in full or in instalments. The instalment payment facility works as follows:

- a. until confirmation of place for the first year students, respectively by October 15 for students from other years of study, at least 25% of the annual tuition fee must be paid;
  - b. by December 5, at least 50% of the annual tuition fee;
  - c. by March 15, at least 75% of the annual tuition fee;
  - d. by May 15, 100% of the annual tuition fee to be paid.
5. Tuition fees (rates) discounts established by the faculties are granted only to Romanian students and equivalent for bachelor level - full time and distance learning (see Annex no. 7), except for faculties granting the master's level special discounts (see Art. 9). Applications for tuition fee discounts are submitted to the faculty secretariats between December 5 to December 15. The tuition fee discount, depending on its amount, applies in all cases to the last and the penultimate instalment as appropriate.
6. For full payment of tuition fee (rate) until confirmation of place, first year students can be granted a 10% discount. This discount also applies to other years of study provided full payment of the tuition fee until October 15 for full time specialisations, respectively until October 31 for distance learning/ part time specialisations.
7. Exception from the provisions of art. 5 are the reductions granted for the 3rd study programme of the same level within UBB covered by this article.

- a. UBB students can benefit from discounts for the second program of study followed in parallel, discounts ranging between 25% and 50% of the annual tuition fee as determined by the Faculty Council. UBB graduates who are enrolled in a second study programme may benefit from the same discounts.
  - b. Tuition fee discounts may be granted to a student for a single study programme. If a student follows simultaneously two majors and one of them is distance learning/ part time learning, the tuition fee discount is granted for the specialization in distance learning/ part time learning. In other cases, the discount is granted for the second specialization.
  - c. Documents attesting to their being enrolled in another study programme within UBB, respectively UBB graduates, are filed in order to establish tuition discounts during the period December 3-15, with the discount request. They must include a statutory declaration that the student does not and has never benefited from another similar discount simultaneously in another programme of studies within UBB.
  - d. The document attesting to their being enrolled in another study programme must be issued between December 5 to 15 and include an entry vouching that the student has no overdue debts in relation to UBB.
8. Students who move on a budgeted place following re-ranking will be refunded the tuition fees (rates) paid in advance for that academic year.
  9. Faculties are free to apply, upon request, the following special discounted tuition fees (rates) with prior in principle approval of the Faculty Council:
    - 9.1. Bachelor level - full time learning and distance learning and master's level - full time learning and part-time learning:
      - a. the 25% discount of the tuition fee for members of the same family (spouse, parents, children or brothers/ sisters) who are students at the

Faculty, enrolled in undergraduate or master's study programmes, provided that everyone have paid the first two instalments of the tuition fee;

- b. tuition fee exemption (100% discount) for orphans of both parents;
- c. tuition fee exemption (100% discount) for students from orphanages enrolled in a master's programme;
- d. 50% discount for students with severe disabilities based on the medical documents submitted.

10. Discounts apply as stepped discounts and accumulation discounts (see explanatory note) and are established for each academic year.

11. Faculties, with prior in principle approval of the Faculty Council, are free to grant employees of Babes-Bolyai University of Cluj-Napoca, based on their written request addressed to the faculty, a discount of more than 50% of:

- a. the annual tuition fee for bachelor level for maximum the normal duration of the specialisation followed by an employee (3 or 4 years), in which case an amendment to the employment contract will be drawn up stipulating that the employee remains in the institution for a period of minimum 3 or 4 years (depending on the period for which tuition discount was approved) (see Annex 9).
- b. Annual tuition fee for master's level, for maximum 2 years, in which case an amendment to the employment contract will be drawn up stipulating that the employee remains in the institution for a period of minimum 2 years (see Annex 9).
- c. the annual tuition fee for doctoral degree, for maximum three years, in which case an amendment to the employment contract will be drawn up stipulating that the employee remains in the institution for a period of minimum 3 years reckoned from the date of public defence of the thesis (see Appendix 9). The discount does not apply to the fee for the public defense of the thesis.

Fixed-term employees in UBB cannot benefit from the provisions of this article.

## 12. Regulations for specific situations:

12.1. **Withdrawal from education** - bachelor, master's, post-doctoral programmes, psycho-pedagogical programmes - Level I and Level II of the Department for Teacher Training (DPPD), doctorate, is done following a filed request approved by the faculty management or head of DTT prior to registration or after registration.

- a. First year students, admitted on tuition will sign the learning agreement upon confirmation of place. If the student submits to the faculty secretariat a registered request to withdraw from studies, within the period of time since signing the agreement to the day preceding the beginning of the academic year, tuition fees (fares) will be fully refunded.
- b. With the exception of first year students, all students who request to withdraw from studies prior to the beginning of the academic year can receive a full refund of the tuition fee paid in advance for the period remaining from the time of withdrawal, by the end of the academic year, according to Article 4. point c and Article 12.1 point c.
- c. After the beginning of the academic year, for registered students attending study programmes on tuition, regardless of the year of study, the tuition due is calculated according to the date of filing the request for withdrawal and in accordance with Art. 3 above, as follows:
  - If the withdrawal request is filed starting October 1 to the end of the first semester the student will owe 50% of the total tuition fee;
  - If the withdrawal request is filed during the second semester the tuition fee will be due entirely;
  - These provisions are closely interrelated with the regulations regarding the organization of study groups and the establishment of teaching loads and funding the resulting costs.
- d. Net fee due at the time of withdrawal will be determined as the difference between the total fee payable and the total fee

paid cumulatively from the beginning of the academic year to which any unpaid fees in previous academic years can be added.

e. The refunding of any amounts of tuition fees will be made only upon request after the withdrawal.

12.2. **Re-enrolment** - Bachelor, Master's level, psycho-pedagogical programmes - Level I and Level II of the DTT (Department for Teacher Training), students will pay together with the re-registration fee any payment due from the preceding academic years of study when they were enrolled in study programmes within UBB and the first instalment of the tuition fee for the academic year in which the re-registration is performed.

12.3. **Interruption of studies** - Bachelor, Master's level, psycho-pedagogical programmes - Level I and Level II of DTT, doctoral studies, students are required to meet the requirements resulting from the updating of the curricula, including those related to tuition fee changes. The tuition fees payable by students enrolled on tuition that require interruption of studies is determined as follows:

- a) After the beginning of the academic year, for registered students attending study programmes on tuition, regardless of the year of study, the tuition due is calculated according to the date of filing the request for withdrawal and in accordance with Art. 3 above, as follows:
  - If the request for interruption of studies is registered in the period beginning October 1st until the end of the first semester the student will owe 50% of the total tuition fee;
  - If the request for interruption of studies is registered during the second semester the tuition fee will be due in full;
- b) Net fee payment at the time of interruption of studies is determined as the difference between the total fee payable and the total fee paid cumulatively from the beginning of the academic year to which any unpaid fees in previous academic

years can be added.

- 12.4. **Student academic mobility from other institutions on tuition places.** Students who benefit from academic mobility follow the regime established for the programme and year of study to which they were transferred. Students will pay corresponding tuition for the academic year in which the academic mobility was operated.
- 12.5. In case of **shifting through redistribution from a place on tuition to a state funded place**, following admission to bachelor's, master's and doctoral programmes as a result of the withdrawal of candidates initially admitted on budgeted places or as a result of supplementing the number of state funded places, candidates are entitled to a tuition fee refund or refund of the instalment paid upon confirmation of place. A place is considered confirmed if the student pays in advance at least one instalment of the tuition fee and signs the learning agreement. Tuition fee refund is based on a request submitted to the Faculty, within a limitation period of 3 years from the date of payment of the tuition.
- 12.6. In case of **shifting from budgeted places on tuition places**, students in years 2, 3 and 4, with a normal track **without interruption of studies** will pay the tuition corresponding to their class.
- 12.7. Regardless of the year of registration, doctoral students on tuition places, including those who extended their period of studies or further their studies, will pay for the public defence of doctoral thesis a fee corresponding to the academic year in which the thesis defence takes place.
- 12.8. The doctoral student extending their period of studies will pay a tuition fee only for the months of the extension, including the month in which the doctoral thesis defence takes place, accounting for 1/9 of the established annual tuition fee.

13. Fee (rate) for sitting for the exams established in Annex no. 5

13.1. Fee (rate) applies to graduates of Babes-Bolyai University of Cluj-Napoca upon a new enrolment as follows:

- in case of failing in two consecutive sessions following enrolment (June February) or only in one of them;
- when the first registration occurs more than 3 years after graduation.

13.2. Fee (rate) paid to register for examination entitles the student to sit for the exams in two consecutive sessions (June, February) of the same academic year.

Fee related to the graduation exam covers both examinations.

14. For graduates of higher education institutions other than the Babes-Bolyai University of Cluj-Napoca, the **costs related to a registration for organizing the graduation exams, diploma exam, respectively dissertation defence** may fall within the range given by the amount provided for in Annex no. 5 to its **double**.

15. For tuition paying students at Babes-Bolyai University, citizens from **states that are not members of the European Union, of the European Economic Area as well as of the Swiss Confederation**, the amount of tuition fees (rates) is established in currency for the 2018/2019 academic year in accordance with Annex no. 4. The following regulations will be taken into consideration:

15.1. A fee of 50 Euro will be paid for processing the admission file, regardless of the level of study or form of education for which the file is submitted.

15.2. For full time students (undergraduate, master's or doctorate):

a. Fees (rates) are paid throughout the duration of the academic year of:

- 9 months for the years of study in which the curricula does not provide a Training course or the Training provided in the curriculum takes place throughout the semester and not as a distinct period of time.
- 10 months for the years of study in which the curricula provide a Training discipline over a period distinct from the teaching activities.

b. Fees (rates) may be paid in full by October 15 without benefiting of any discount or in instalments, according to art. 4 of this decision.

c. Fees (rates) set out in Annex no. 4 do not include the cost of accommodation, respectively meals.

15.3. For the undergraduate, master's and doctoral study programmes - part time education and other programmes of study, according to Annex no. 4, organized under the law for each year of study, fees (rates) are paid in advance for three months, at the amount set for full time education, according to annex no. 4.

Fees (rates) thus determined shall be paid in full prior to the first session of exams.

15.4. For the graduation exam, dissertation defence, and doctoral thesis defence during the 2018/2019 academic year the amount of fees (rates) is provided in Annex no. 6.

a) Any other personal expenses are provided by those concerned (including accommodation, meals and transportation).

16. Upon its entering into force the present decision shall abrogate the Decision of the Senate of the Babes-Bolyai University from Cluj-Napoca No. 1757/6.02.2017 and annexes.

18. The Administration Council must provide the dean's office and management of CFCIDFR (Centre for Continuing education, distance learning and part-time learning) standard forms of learning agreements in accordance with the provisions of this decision.
19. For failure to pay in due time the fees established by this decision a penalty of 0.04% is due for each day of delay from the due date of the payment obligation until actual payment.

Explanatory Note to art. no 9 of above Regulation:

### 1st example:

Student, undergraduate level, who studies at Faculty X, the first specialisation A (2nd year) and the second specialisation B (first year). *Pays tuition to the 2nd specialisation in advance and in full (until 15 October 2018).*

*The annual tuition fee for specialisation B: 2,500 lei (see Annex no. 3)*

*Discount for the 2nd specialisation: 50% (see Annex no. 7)*

*Discount for prepayment and full payment: 10% (see art. 5 of the above decision)*

The **fee due** for specialization B =  $(1-0.10) \times (1-0.50) \times 2,500 = 0.90 \times 0.50 \times 2,500 = 1,125$  lei

### 2nd example:

A student in the bachelor level, graduate of the "Babes-Bolyai" University of Cluj-Napoca, is enrolled in a second specialisation within Faculty Y (1st year of study). Pays tuition to the 2nd specialization in advance and in full (until October 15, 2018).

*The annual tuition fee pertaining to a specialization: 2,400 lei (see Annex no. 3)*

*Tuition discount for being an UBB graduate: 25% (see Annex no. 7)*

*Discount for prepayment and full payment: 10% (see art. 5 of the above decision).*

*The tuition fee due =  $(1-0.10) \times (1-0.25) \times 2,400 = 0.90 \times 0.75 \times 2,400 = 1,620$  lei.*
